Yinghua Academy is a tuition-free public charter Mandarin Chinese Immersion School in Minneapolis, Minnesota, serving K-8th grades. Our rigorous curriculum is based on the Core Knowledge Sequence, Minnesota academic standards and national standards for foreign language learning. The Academy students demonstrate excellent academic achievement in core subjects, high levels of Chinese language proficiency, and achievement in physical education, music, and the arts. The Academy helps students understand the people, cultures, history and heritage of China and other world cultures. Chinese traditions and festivals weave Chinese culture into the curriculum throughout the year. Native Chinese teachers, residencies with local artists and musicians, experiential learning, field trips, afterschool enrichment, student life activities, and study abroad all enhance instruction.

FLAP grant - The Foreign Language Assistance Program (FLAP) is administered by the US Department of Education. Yinghua received a no-cost extension for a 4th year of FLAP grant funding: the total program period was from 9/1/2009-8/30/2013. The grant helped Yinghua Academy establish a middle school program focused on increasing study of Chinese language in both minutes of instruction and language proficiency. With FLAP funding, Yinghua Academy developed a curriculum scope and sequence for Chinese language learning using immersion teaching methods at the middle school level,

established a sister-school relationship and a study abroad component in China, provided for assessment of student language proficiency and literacy, and supported teacher professional development and collaborations with other institutions.

STARTALK grant - The federal National Security Agency (NSA) STARTALK program provides summer programming in Chinese language teaching and learning. The 2013 STARTALK-funded program at Yinghua Academy included a student Chinese immersion summer camp and a teacher training program. The two-week student summer camp "From Abacus to Apps: Learning Chinese Language and Culture through Science, Math and Technology" served 116 students in grades K-4. The three-week STARTALK IMPACT (Immersion Mandarin Professionals Acquire Coaching and Training) Program provided teacher professional development, experiential internship, and mentoring to 15 new and novice Chinese immersion teachers.
