- Recognized by China as one of five outstanding Chinese language schools worldwide.



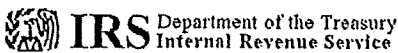
